- Length of full paper Paper should comprise not more than 3000 to 4000 words in single column MS-Word format
- Font: Times New Roman
- Font size Head 14 Bold, Body 12 (Line spacing 1.5 and alignment "justify" with 1" inch margin on all sides)
- The paper must highlight specific research problem and adhere to appropriate research methodology.
- Tables and figures should be standard format with source (mandate) and footnote (if any)
- Author(s) should submit Hindi, Kannada and Sanskrit papers only in MS-Word.
- Hindi (font style Mangal, font size 14); Kannada (font style – Nudi 1E, font size – 14); Sanskrit (font style – Devanagari, font size – 14).
